**Subject: Weekly Indemnity Disability Benefit Modification**

The attached letter will be sent out to Active ILWU-PMA Welfare Plan members in Oregon and Washington advising them the basic Weekly Indemnity maximum benefit is increasing from \$775 to \$875. The increase applies to claims beginning on or after April 2, 2016. In addition, the employee contribution will decrease from 1.35% to 1.25% of earnings effective the payroll period ending April 8, 2016.

Re: Weekly Indemnity Disability Benefit Modification

For Weekly Indemnity Disability Claims beginning on or after April 2, 2016, the basic Weekly Indemnity maximum benefit will increase from \$775 to \$875. Weekly Indemnity benefits are based on your average earnings in the highest quarter of your Base Period. A chart showing the benefit levels and a description of the Base Period is printed on the back of this sheet.

The Non-Industrial Disability Supplement Benefit of \$125.00 per week is unchanged.

Effective April 2, 2016 (payroll period ending April 8, 2016), the employee contribution to the ILWU-PMA Welfare Plan will decrease from 1.35% to 1.25% of earnings.
